I am writing this to draw your kind attention on the following important issues relating to the waqf properties which have come to the notice of this Ministry:

- i. Various waqf properties have been illegally sold in collusion with the officials of revenue department, Muttawalli & land grabbers;
- ii. Most of the waqf properties have not been registered as "waqf" in the revenues records;
- iii. Muttawalli in collusion with the officials of revenue department have registered such waqf properties in their name and become the owner of waqf properties.

2. In the above context, you are kindly requested to look into the matter and issues necessary directions to the State Waqf Boards, Revenue Departments and other concerned authorities to make efforts that all the waqf properties in your State must be recorded as a "waqf" in the revenue records. A detailed letter has already been sent to you earlier on the subject (copy enclosed).

As you are aware, this Ministry implements Qaumi Waqf Board Taraqqiati Scheme (QWBTS) through the Central Waqf Council, a statutory body of the Ministry. One of the major components of the scheme is GIS/GPS mapping of Waqf properties to prevent encroachment of Waqf properties. GIS mapping of all the waqf properties in various States are continuing and are on ongoing process. During the recent video conferencing held with State Governments, Waqf Boards and various Agencies who are doing the work of GIS mapping of waqf properties, it emerged that there are challenges/issues in identifying waqf properties for proper GIS mapping work as well as monitoring the ongoing work. Many of the waqf properties are not being recorded in Revenue records as waqf properties and this needs to be done on priority. Considering the facts and circumstances, it is desirable that the District Minority Welfare Officer and representative of revenue officials get associated with the process closely. This will help in further enabling the process of GIS mapping of waqf properties in a seamless and expeditious manner and to ensure that waqf properties are registered as "waqf" in Revenue records as well.

Hence, you are kindly requested to issue suitable directions to District Minority Welfare Officers, concerned local Revenue Officials and State Waqf Boards to co-operate, work together to achieve the desired objectives for proper implementation of the scheme.
